(1) The number of securities reported represents an aggregate number of shares purchased in multiple market transactions over a range of purchase prices. The Reporting Person undertakes to provide the staff of the SEC, the Issuer, or a stockholder of the Issuer, upon request, the number of shares purchased by the Reporting Person at each separate price within the range.

Pursuant to the Amended and Restated Investor Agreement, dated as of January 11, 2014, by and among Sanofi, SAAN, sanofi-aventis US LLC, Aventis (collectively, the "Sanofi Parties") and the Issuer, the Sanofi Parties have agreed to vote their respective shares of the Issuer, subject to specified exceptions, in accordance with the recommendation of the Issuers Board of Directors.

(5) Purchase prices range from \$328.45 to \$329.43 per share, inclusive.

(6) Purchase prices range from \$329.50 to \$330.49 per share, inclusive.

(7) Purchase prices range from \$330.50 to \$331.49 per share, inclusive.
