- (1) Each restricted stock unit represents a contingent right to receive one share of common stock of Ryerson Holding Corporation. On August 17, 2015, the reporting person was granted 11,600 restricted stock units, of which 5,000 vested on August 31, 2015. Of the remaining unvested restricted stock units, 2,200 vest on August 17, 2016, 2,200 vest on August 17, 2017 and 2,200 vest on August 17, 2018. Vested shares will be delivered to the reporting person not later than 60 days following such vesting dates.
- (3) The purpose of this amendment is to correct the number of shares reported under Column 7 of Table II. The original Form 4, filed September 1, 2015, erroneously reported 11,600 shares under Column 7 of Table II.
- (4) The restricted stock units reported as disposed herein were settled for shares of common stock of Ryerson Holding Corporation.
