1. Aggregated Market Value was determined by using the closing share price on January 10, 2018, which was \$56.00 per share.
2. Shares outstanding as of October 27, 2017.
3. Shares acquired in 2008 under Northwest Natural Gas Company's Deferred Compensation Plan for Directors and Executives (DCP) for services rendered by Mr. Dodson as an employee of the Company, and paid on an ongoing basis over the life of Mr. Dodson's DCP account, pursuant to elections made by Mr. Dodson on December 10, 2007.
4. 1,036 shares of 3,980,491 shares of common stock distributed from Mr. Dodson's DCP account were sold to cover taxes.
5. Cash or stock paid by the Company as compensation for services rendered by Mr. Dodson as an employee of the Company, at the then current fair market value, which was determined at the time of compensation grant.
