- Name of Person Filing: This joint statement on Schedule 13G is being filed by Peter Kolchinsky, RA Capital Management, LLC, RA Capital Healthcare Fund, L.P. and RA Capital Healthcare Fund II, L.P., who are collectively referred to herein as the "Reporting Persons." Mr. Kolchinsky (the "Manager") is the manager of RA Capital Management, LLC ("Capital"), which is the investment adviser and sole general partner of each of RA Capital Healthcare Fund, L.P. ("Fund I") and RA Capital Healthcare Fund II, L.P. ("Fund II"). The Reporting Persons have entered into a Joint Filing Agreement, dated as of the date hereof, a copy of which is filed with this Schedule 13G as Exhibit 1 (which is incorporated herein by reference), pursuant to which the Reporting Persons have agreed to file this statement jointly in accordance with the provisions of Rule 13d-1(k) under the Act.

In the aggregate, the Reporting Persons beneficially own 1,494,762 shares of the Common Stock representing approximately 8.4% of such class of securities. The Reporting Persons have the right to purchase an additional 246,167 shares of Common Stock pursuant to the terms of a warrant issued on December 19, 2008; however, pursuant to the terms of such warrant, such shares are not exercisable within 60 days of the date of this filing.

The beneficial ownership of each Reporting Person is as follows: (i) Fund I beneficially owns 1,481,140 shares of Common Stock representing approximately 8.3% of the class, (ii) Fund II beneficially owns 13,622 shares of Common Stock representing approximately 0.1% of the class and (iii) Capital, as the investment adviser and sole general partner of each of Fund I and Fund II, and the Manager, as the manager of Capital, each beneficially owns 1,494,762 shares of Common Stock of the Issuer representing approximately 8.4% of the class. The percentage of the Common Stock beneficially owned by each Reporting Person is based on a total of 17,781,392 shares of Common Stock of the Issuer, which includes 15,044,056 shares of Common Stock of the Issuer outstanding as of November 3, 2008, as reported in the most recently quarterly report of the Issuer on Form 10-Q for the fiscal quarter ended

September 30, 2008, and an additional 2,737,336 shares of Common Stock reported by the Issuer in a prospectus dated January 20, 2009.
