(a) **Name of Issuer:** Arrowhead Research Corporation (the “Issuer”).

(a) **Name of Person Filing:** This joint statement on Schedule 13G is being filed by Peter Kolchinsky, RA Capital Management, LLC, and RA Capital Healthcare Fund, L.P., who are collectively referred to herein as the “Reporting Persons.” Mr. Kolchinsky (the “Manager”) is the manager of RA Capital Management, LLC (“Capital”), which is the investment adviser and sole general partner of RA Capital Healthcare Fund, L.P. (“Fund”) and serves as the investment adviser to a separate discretionary account.

(b) **Address of Principal Business Office:** The principal business office of the Reporting Persons is c/o RA Capital Management, LLC, 20 Park Plaza, Suite 1200, Boston, MA 02116.

(c) **Citizenship:** Capital is a Massachusetts limited liability company. The Fund is a Delaware limited partnership. The Manager is a United States citizen.

(d) **Title and Class of Securities:** Common stock (“Common Stock”).

(e) **CUSIP Number:** 042797209.

**Item 4. Ownership:**

As of the date of this filing, the Reporting Persons, in the aggregate, beneficially own 3,114,755 shares of the Common Stock of the Issuer, representing approximately 9.9% of such class of securities. The Reporting Persons also own 6,300 shares of Series B Preferred Stock that are convertible into 3,442,623 shares of Common Stock. The beneficial ownership of each Reporting Person is as follows: (i) Fund beneficially owns 2,491,804 shares of Common Stock representing approximately 8.0% of the class and also 5,040 shares of Series B Preferred Stock that are convertible into 2,754,098 shares of Common Stock and (ii) Capital, as the investment adviser and sole general partner of the Fund and investment adviser to an account owned by a separate investment vehicle which holds shares of the Issuer's Common Stock, and Mr. Kolchinsky as the manager of Capital, each beneficially own 3,114,755 shares of Common Stock of the Issuer representing approximately 9.9% of the class and also 6,300 shares of Series B Preferred Stock that are convertible into 3,442,623 shares of Common Stock. The Series B Preferred Stock referred to above may not be converted such that the number of shares of common stock held by the Reporting Persons after such conversion exceeds 9.99% of the outstanding shares of common stock ("Beneficial Ownership Limitation"). The Preferred Shares are eligible to vote with the common stock of the Company on an as-converted basis, but only to the extent that the Preferred Shares are eligible for conversion without exceeding the Beneficial Ownership Limitation.

The Fund has the power to vote and dispose of the shares of Common Stock beneficially owned by such entity (as described above). Capital, as the investment adviser and sole general partner of the Fund and as the investment adviser to an account owned by a separate investment vehicle which holds shares of the Issuer's Common Stock, has the authority to vote and dispose of all of the shares of Common Stock reported in this Schedule 13G. The Manager, by virtue of his position as manager of Capital, has the authority to vote and dispose of all of the shares of Common Stock reported in this Schedule 13G.
