(a) The name of the issuer is Recro Pharma, Inc. (the “*Issuer*”).

(b) The principal executive offices of the Issuer are located at 490 Lapp Road, Malvern, PA 19355.

(a) This statement (this “*Statement*”) is being filed by: (1) Avet Capital Partners Master Fund, LP, a Cayman Islands exempted limited partnership (the “*Fund*”); (2) Avet Capital Management, LLC, a Delaware limited liability company (the “*Investment Manager*”); (3) Avet Capital GP, LLC, a Delaware limited liability company (the “*General Partner*”); and (4) Norbert Gottesman (all of the foregoing, collectively, the “*Filers*”). The Fund is a private investment vehicle and directly owns all of the shares reported in this Statement (other than 6,000 shares owned directly by Mr. Gottesman). The Investment Manager is the investment manager to the Fund. The General Partner is the general partner of the Fund. Mr. Gottesman is Managing Member of the Investment Manager and the General Partner and is the Portfolio Manager for the Fund. The Investment Manager, the General Partner and Mr. Gottesman may be deemed to beneficially own the shares owned directly by the Fund. Each Filer disclaims beneficial ownership with respect to any shares other than those owned directly by such Filer.
