Item 1.01 Entry into a Material Definitive Agreement

On November 13, 2015, Global Defense & National Security Systems, Inc. (the "Company") issued a convertible promissory note in the amount of \$711,447 to Global Defense &National Security Holdings LLC (the "Lender"). The convertible note is due on the earlier of (1) November 24, 2015, and (2) immediately following the consummation of the initial Business Combination (as defined in the Company's Amended and Restated Certificate of Incorporation). At the Lender's election, upon the Business Combination, the note will convert into the Company's common stock, par value \$0.0001, at a price equal to the greater of (1) \$10.00 per share, and (2) the 30-day trailing average of the closing price per share. Funds in the Trust Account (as defined in the Company's Amended and Restated Certificate of Incorporation) will not be used to repay the note.
