Partner Communications Reports on an Interim Decision by the National Council for Planning and Building Regarding Licensing of Cell Sites

Rosh Ha'ayin, Israel, January 3, 2006 Partner Communications Company Ltd. (NASDAQ, TASE: PTNR, London: PCCD) reported today that the National Council for Planning and Building published an interim decision conditioning the issuance of cell site permits by local planning and building councils upon indemnification, against reduction in property value claims, by the cellular operators.

This interim decision may affect the Company's, and the other cellular operators' plans, in expanding and enhancing network coverage.

Partner Communications Company Ltd. (Partner) is a leading Israeli mobile communications operator providing GSM/ GPRS/ UMTS services and wire free applications under the orange brand. The Company commenced full commercial operations in January 1999 and, through its network, provides quality service and a range of features to 2.5 million subscribers in Israel (as of December 2005). Partner subscribers can use roaming services in 162 destinations using 347 GSM networks. The Company launched its 3G service in 2004.
