BETWEEN PARTNER AND 012 SMILE

ROSH HA'AYIN, Israel, December 21, 2011 - Partner Communications Company Ltd. ("Partner" or "the Company") (NASDAQ and TASE: PTNR), a leading Israeli communications operator, announces today the termination of the limited period of time during which a structural separation between Partner and its fully owned subsidiary, 012 Smile Telecom Ltd. ("012 Smile"), was required, following the official governmental publication, dated December 14, 2011, of the Director of the Ministry of Communications announcement, dated December 8, 2011, with respect to the commencement of operation of a Mobile Virtual Network Operator (MVNO).

Mr. Haim Romano, Partner's CEO, said: "We welcome this positive development that will enable us to advance the process of reaping the benefits of the 012 Smile acquisition and Partner's transformation into a comprehensive communications group."

This press release is pursuant to the Company's press release and immediate report dated March 3, 2011.
