Represents the Restricted Stock Unit (RSU) award granted on February 24, 2015, and previously reported on February 26, 2015. Each (1) RSU represents a contingent right to receive one share of Casella's Class A Common Stock. RSU's vest in three equal installments beginning on February 24, 2016.

This amendment is being filed solely to correct the number of shares of Class A Common Stock directly beneficially owned. The number of shares of Class A Common Stock directly beneficially owned shown in Table I, column 5 of the Form 4 filed on February 26, 2015 (the "Original Form 4") overstated 11,541 shares of Class A Common Stock. The number of shares of Class A Common Stock directly (2) beneficially owned as shown in Table I, column 5 of this amendment represents the correct number of shares of Class A common stock directly beneficially owned by Mr. Schmitt following the transaction previously reported in the Original Form 4. The first overstated reporting of the direct beneficial ownership total by Mr. Schmitt was in a Form 4 filed on July 1, 2013, and this total was carried forward in subsequent Form 4 filings until and including the Original Form 4.
