(2) The following shares are directly owned: (i) 1,099,192 outstanding shares; (ii) 714,286 shares that are not outstanding, but which may be acquired pursuant to currently exercisable warrants; (iii) 450,000 shares that are not outstanding, but which may be acquired pursuant to currently exercisable options and (iv) 34,378 shares that are not outstanding, but which may be acquired upon conversion of 6 1/2% convertible quarterly income preferred securities (Convertible QUIPS) issued by a subsidiary trust of United Rentals, Inc.
