Explanation of Responses:

(1) 150,000 Options with an exercise price of \$36.09; 50,000 Options with an exercise price of \$24.35; 70,000 with an exercise price of \$15.37; and 75,000 with an exercise price of \$15.37.

(2) On September 24, 2002 Mr. Taneja tendered to issuer, for cancellation, 345,000 Options granted to him on 12/10/1999, 8/7/2001, and 3/15/2002.

(3) 150,000 Options vesting 25% per year on the anniversary of 12/10/1999 (grant date) over a four year period; commencing 2 years from the grant date, 20% on the anniversary of 8/7/2002 (grant date) over a five year period; 70,000 vesting 25% a year on the anniversary of 3/15/2002 (grant date) over a four year period; 75,000 vesting 50% on the anniversary of 3/15/2002 (grant date) over a 2 year period.

(4) 150,000 expire on 12/10/2009; 50,000 expire on 8/7/2011; 145,000 expire on 3/15/2009.
