Unilever NV also announces that 114,477 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 65,647,464 Unilever NV ordinary shares in treasury, and has 1,649,080,236 Unilever NV ordinary shares in issue (excluding treasury shares).
