Unilever NV announces that on 19 October 2007 it purchased 102,500 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 22.250 and euro 22.300 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 69,336 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 100,384,710 Unilever NV ordinary shares in treasury, and has 1,614,342,990 Unilever NV ordinary shares in issue (excluding treasury shares).
