**Item 5. Other Events and Regulation FD Disclosure.**

On December 10, 2003, Manpower Inc., a Wisconsin corporation ( Manpower ), announced that it had entered into an Agreement and Plan of Merger (the Merger Agreement ), dated as of December 10, 2003, with Right Management Consultants, Inc., a Pennsylvania corporation ( Right ), and Hoosier Acquisition Corp., a Pennsylvania corporation and a wholly-owned subsidiary of Manpower ( Merger Sub ). In connection with the merger, Manpower entered into a tender and voting agreement (the Tender and Voting Agreement ), dated as of December 10, 2003, with certain shareholders of Right. The Merger Agreement and the Tender and Voting Agreement are attached hereto as exhibits and incorporated herein by reference.

This announcement is not a recommendation, an offer to purchase or a solicitation of an offer to sell Manpower Common Stock. Merger Sub has not commenced the Offer. Upon the commencement of the Offer, Manpower and Merger Sub will file with the Securities and Exchange Commission (the Commission ) a tender offer statement on Schedule TO (the Tender Offer Statement ) and a Registration Statement on Form S-4 (the Registration Statement ), and Right will file with the Commission a solicitation/recommendation statement on Schedule 14D-9 (the Recommendation Statement ). Shareholders of Right are advised to read the Tender Offer Statement, the Registration Statement and the Recommendation Statement when they become available, as they will contain important information about Right, Manpower, the Offer and the Merger.
