On January 16, 2007, Michael C. Franson was elected to the Board of Directors of Northwest Pipe Company (the Company) for a term expiring at the Company's 2007 Annual Meeting of Shareholders. Mr. Franson has been elected to serve on the Compensation Committee of the Board of Directors.
