Officers of WellPoint, Inc. (WellPoint) expect to meet with securities analysts and investors during the period commencing on January 7, 2008 and ending on January 8, 2008. During these meetings, the officers expect to confirm WellPoint's ability to meet the earnings per share expectations given in a press release and webcast on December 11, 2007 and in a press release and conference call on October 24, 2007.
