On August 19, 2009, Philip R. Johnson, Vice President, Human Resources of Asbury Automotive Group, Inc. Commencing on September 19, 2009, Mr. Johnson's broker may sell up to 15,517 shares of the Company's common stock at specified minimum market prices through June 4, 2010, upon the exercise of options granted to Mr. Johnson on June 5, 2000, that expire on June 5, 2010. The Plan terminates on June 4, 2010, unless terminated at an earlier date in accordance with its terms.

Specific sales transactions under the Plan will be disclosed publicly through Form 4 filings with the Securities and Exchange Commission.
