Attached is an English translation of the summary of the letter dated December 29, 2010 filed by the Company with the *Bolsa de Comercio de Buenos Aires* and the *Comisión Nacional de Valores*.

By letter dated December 29, 2010, the Company reported that pursuant to the resolution decided by the Shareholders Meeting held on December 9, 2010 and its Board of Directors Meeting held on December 27, 2010, it decided to grant a cash dividend to its shareholders for an amount of Ps. 69,000,000 (Argentina legal currency), pro rata to their shareholdings. The cash dividend will be available for shareholders as from January 7, 2011 and will be equivalent to 13.895596843% of the Company's share capital, and an amount per face value share of Arg. \$0.13895596843 and an amount per ADR's of Arg. \$1.3895596843. The cash dividend will be paid in favor of all shareholders duly registered in Caja de Valores S.A.'s records before January 6, 2011. For shareholders holding registered shares, the payment will be subject to evidence of their identity, and will take place in Caja de Valores S.A. located at N°362, 25 de Mayo Street, City of Buenos Aires, Argentina, from Monday to Friday between 10 a.m. to 3 p.m.
