On May 17, 2011, Exelon Corporation (Exelon) and Constellation Energy Group, Inc. (Constellation) filed an application for approval by the Public Utility Commission of Texas (PUCT) of the proposed merger announced by the companies on April 28, 2011. On August 3, 2011, the PUCT approved the merger application.
