**Item 5.07. Submission of Matters to a Vote of Security Holders.**

Exelon Corporation ( Exelon ) held a special meeting of shareholders on November 17, 2011 to consider two proposals relating to the proposed merger of Exelon Corporation and Constellation Energy Group, Inc. ( Constellation ) under the terms of the Agreement and Plan of Merger, dated as of April 28, 2011, by and among Exelon, Bolt Acquisition Corporation, a wholly-owned subsidiary of Exelon, and Constellation (the Merger ).

The shareholders approved the share issuance proposal relating to the Merger. Sufficient votes were received to approve the adjournment proposal, although the adjournment proposal is not needed following the approval of the share issuance proposal. For more information on the proposals, see Exelon s proxy statement/prospectus included in the registration statement filed with the U.S. Securities and Exchange Commission (the SEC ) declared effective by the SEC on October 11, 2011. Set forth below are the final voting results for each of the proposals.

**1. Proposal to approve the issuance of Exelon common stock, without par value, to Constellation stockholders in connection with the Merger.**
