QVT Financial LP ( QVT Financial ) is the investment manager for QVT Fund LP (the Fund ), which beneficially owns 923,596 shares of Common Stock. QVT Financial is also the investment manager for Quintessence Fund L.P. ( Quintessence ), which beneficially owns 98,627 shares of Common Stock. QVT Financial has the power to direct the vote and disposition of the Common Stock held by each of the Fund and Quintessence. Accordingly, QVT Financial may be deemed to be the beneficial owner of an aggregate amount of 1,022,223 shares of Common Stock, consisting of the shares owned by the Fund and Quintessence.

QVT Financial GP LLC, as General Partner of QVT Financial, may be deemed to beneficially own the same number of shares of Common Stock reported by QVT Financial. QVT Associates GP LLC, as General Partner of the Fund and Quintessence, may be deemed to beneficially own the aggregate number of shares of Common Stock owned by the Fund and Quintessence, and accordingly, QVT Associates GP LLC may be deemed to be the beneficial owner of an aggregate amount of 1,022,223 shares of Common Stock.

The percentage disclosed in Item 11 of the Cover Pages for each reporting person is calculated based upon 25,120,032 shares of Common Stock outstanding, which is the total number of shares issued and outstanding as reported in the Issuer's Form 6-K, filed with the Securities and Exchange Commission on August 17, 2011.
