QVT Financial LP (QVT Financial) is the investment manager for QVT Fund IV LP (Fund IV), which beneficially owns 501,360 shares of Common Stock, for QVT Fund V LP (Fund V), which beneficially owns 2,956,894 shares of Common Stock, and for Quintessence Fund L.P. (Quintessence), which beneficially owns 434,628 shares of Common Stock. QVT Financial has the power to direct the vote and disposition of the Common Stock held by Fund IV, Fund V and Quintessence. Accordingly, QVT Financial may be deemed to be the beneficial owner of an aggregate amount of 3,892,882 shares of Common Stock, consisting of the shares owned by Fund IV, Fund V and Quintessence.

QVT Financial GP LLC, as General Partner of QVT Financial, may be deemed to beneficially own the same number of shares of Common Stock reported by QVT Financial. QVT Associates GP LLC, as General Partner of Fund IV, Fund V and Quintessence, may be deemed to beneficially own the aggregate number of shares of Common Stock owned by Fund IV, Fund V and Quintessence, and accordingly, QVT Associates GP LLC may be deemed to be the beneficial owner of an aggregate amount of 3,892,882 shares of Common Stock.
