**Explanatory Note**

On December 14, 2012, the stockholders of Tiger Media, Inc. (the "Company") approved an amendment of the Company's Amended and Restated 2008 Stock Incentive Plan (the "Plan") at the Company's 2012 Annual General Meeting of Shareholders to increase the aggregate number of shares of the Company's ordinary stock, \$0.0001 par value (the "Ordinary Stock"), authorized for issuance under the Plan by 1,500,000 shares of Ordinary Stock from 3,000,000 shares of Ordinary Stock to 4,500,000 shares of Ordinary Stock.

The Company previously filed a Registration Statement on Form S-8 on September 27, 2011 (File No. 333-177025) registering the issuance of the initial 3,000,000 shares of the Company's Ordinary Stock under the Plan (the "Earlier Registration Statement"). The additional shares to be registered by this Registration Statement are of the same class as those securities covered by the Earlier Registration Statement. Pursuant to General Instruction E to Form S-8, the contents of the Earlier Registration Statement are incorporated herein by reference, except to the extent supplemented, amended or superseded by the information set forth herein.
