**Item 2.02 Results of Operations and Financial Condition; Item 7.01 Regulation FD Disclosure**

In a Form 8-K filed on July 18, 2013, Fifth Third reported second quarter 2013 net income of \$603 million, net income to common shareholders of \$594 million, earnings per fully diluted share of \$0.66, and noninterest expense of \$1,017 million.

Subsequent to its earnings release, Fifth Third obtained new information related to a litigation loss contingency that resulted in the related reserve being increased by \$18 million to reflect the change in circumstances. This adjustment increased second quarter 2013 noninterest expense by \$18 million, reduced quarterly net income and net income to common shareholders by \$12 million, and reduced quarterly earnings per fully diluted share by \$0.01.

As a result, Fifth Third expects that results reported in its second quarter 2013 10-Q filing will include second quarter 2013 net income of \$591 million, net income to common shareholders of \$582 million, earnings per fully diluted share of \$0.65, and noninterest expense of \$1,035 million.
