Pursuant to General Instruction E to Form S-8 under the Securities Act of 1933, as amended (the Securities Act), this Registration Statement is filed for the purpose of registering (1) 500,000 shares of the Registrant's Common Stock issuable under the Registrant's Amended and Restated 1993 Employee Stock Purchase Plan, and (2) 1,100,000 shares of the Registrant's Common Stock issuable under the Amended and Restated 2012 Equity Incentive Plan, which Common Stock is the same class as those previously registered on Registration Statement on Form S-8s and filed with the Securities and Exchange Act Commission (the SEC) on August 10, 2012 (File No. 333-183219), on June 28, 2011 (File No. 333-175172), on August 10, 2009 (File No. 333-161206), on June 9, 2008 (File No. 333-151527), on January 1, 2007 (File No. 333-140233), on June 22, 2006 (File No. 333-135220), on January 27, 2006 (File No. 333-131324), on July 21, 2005 (File No. 333-126773), on February 2, 2004 (File No. 333-112417), and on September 19, 2003 (File No. 333-108937). The contents of the aforementioned Registration Statements, including any amendments thereto or filings incorporated therein, are incorporated herein by reference.
