ITEM 1. SECURITY AND ISSUER

Item 1 of the Schedule 13D is hereby amended and restated as follows:

This Amendment No. 6 (this <u>Amendment No. 6</u>) amends and supplements the statement on Schedule 13D filed on October 8, 2010 (the <u>Original 13D</u>), as amended and supplemented by amendment No. <u>1</u> (<u>Amendment No. 1</u>), filed on August 10, 2011, amendment No. 2 (<u>Amendment No. 2</u>), filed on January 3, 2013, amendment No. <u>3</u> (<u>Amendment No. 3</u>), filed on January 31, 2014, amendment No. <u>4</u> (<u>Amendment No. 4</u>), filed on February 18, 2014, and amendment No. 5 (<u>Amendment No. 5</u>), filed on April 15, 2014 (the Original 13D as amended and supplemented by amendment No. 1, Amendment No. 2, Amendment No. 3, Amendment No. 4, Amendment No. 5 and this Amendment No. 6, the <u>Schedule 13D</u>), by (i) Pershing Square Capital Management, L.P., a Delaware limited partnership (<u>Pershing Square</u>), (ii) PS Management GP, LLC, a Delaware limited liability company (<u>PS Management</u>) and (iii) William A. Ackman, a citizen of the United States of America (together with Pershing Square and PS Management, the <u>Reporting Persons</u>), relating to the Common Stock, par value \$3.125 per share (the <u>Common Stock</u>), of Beam, Inc., a Delaware corporation (the <u>Issuer</u>), the successor to Fortune Brands, Inc. (<u>Fortune Brands</u>). On or about October 4, 2011, the Issuer changed its name and CUSIP number pursuant to a merger between the Issuer, a wholly owned subsidiary of Fortune Brands, and Fortune Brands, with the Issuer continuing as the surviving corporation in the merger. The principal executive offices of the Issuer are located at: 510 Lake Cook Road, Deerfield, Illinois 60015. Capitalized terms used herein but not defined herein shall have the meaning set forth in the Schedule 13D.

As of April 17, 2014, the Reporting Persons beneficially owned an aggregate of 5,618,545 shares of Common Stock, representing approximately 3.4% of the outstanding shares of Common Stock of the Issuer. As the Reporting Persons no longer beneficially own in excess of 5% of the Issuer s Common Stock, this Amendment No. 6 constitutes the final amendment to the Schedule 13D.

ITEM 4. PURPOSE OF TRANSACTION

Item 4 of the Schedule 13D is amended and supplemented to include the information included in Exhibit 99.1 hereto.

ITEM 5. INTEREST IN SECURITIES OF THE ISSUER

Based upon disclosure in the Issuer s Proxy Statement filed with the U.S. Securities and Exchange Commission on February 19, 2014, there were 165,452,466 shares of the Common Stock outstanding as of February 18, 2014.

Based on the foregoing, the 5,618,545 shares of the Common Stock (the <u>Subject Shares</u>) beneficially owned by the Reporting Persons represent approximately 3.4% of the shares of the Common Stock issued and outstanding.

Pershing Square, as the investment adviser to the Pershing Square Funds, may be deemed to have the shared power to vote or direct the vote of (and the shared power to dispose or direct the disposition of) the Subject Shares. As the general partner of Pershing Square, PS Management may be deemed to have the shared power to vote or to direct the vote of (and the shared power to dispose or direct the disposition of) the Subject Shares. By virtue of William A. Ackman s position as the Chief Executive Officer of Pershing Square and managing member of PS Management,

William A. Ackman may be deemed to have the shared power to vote or direct the vote of (and the shared power to dispose or direct the disposition of) the Subject Shares and, therefore, William A. Ackman may be deemed to be the beneficial owner of the Subject Shares.
