Greif, Inc. (the Company) is unable to file its Form 10-K for the fiscal year ended October 31, 2014 (the 2014 Form 10-K) within the prescribed time period without unreasonable effort or expense due to the reasons described below.

As previously reported in its Form 8-K filings, the Company engaged a new independent registered public accounting firm during the fourth quarter of 2014. Also as previously reported, as a result of impairment indicators that occurred during the fourth quarter of 2014, the Company expects to record a non-cash impairment charge as of October 31, 2014 that may represent a material portion of the goodwill associated with its Flexible Products & Services segment. The extensive analysis and assessment of this non-cash impairment charge and its financial statement impact, despite diligent efforts, has not been completed as of the date hereof. Lastly, the Company is finalizing the assessment of differences arising from the reconciliation of deferred tax accounts for a variety of international locations. This analysis has also not been completed as of the date hereof.

Due to the issues noted above, the Company has not completed its financial statements for the fiscal year ended October 31, 2014. The Company currently expects to file the 2014 Form 10-K within 15 calendar days from the prescribed due date.
