On September 1, 2015, Synopsys, Inc. (*Synopsys*) issued a press release announcing that its board of directors had replenished Synopsys' existing stock repurchase program up to \$500 million. The program authorizes, but does not obligate, Synopsys to purchase up to \$500 million of its common stock, and Synopsys' chief financial officer or board of directors may suspend or terminate the program at any time.
