Linked to the S&P 500[®] Index

Instead, the securities provide for a Redemption Amount that may be greater than, equal to or less than the Principal Amount of the securities, depending on the performance of the Index from the Starting Level to the Ending Level.

The Redemption Amount will reflect the following terms:

If the level of the Index increases:

You will receive the Principal Amount plus 125% participation in the upside performance of the Index, subject to a maximum total return at maturity of 85% to 90% (to be determined on the Principal Date) of the Principal Amount

If the level of the Index decreases, but the decrease is not more than 15%, or equals the Starting Level:

You will be repaid the Principal Amount

If the level of the Index decreases by more than 15%:

You will receive less than the Principal Amount and will have 1-to-1 downside exposure to the decrease in the level of the Index in excess of 15%

(i) \$1,000 *plus*

Ending LevelStarting Level\$1,000 xx Participation Rate\$tarting Level

(ii) the Capped Value

If the Ending Level is less than or equal to the Starting Level, but greater than or equal to the Threshold Level, the Redemption Amount will be equal to \$1,000

If the Ending Level is less than the Threshold Level, the Redemption Amount will be equal to \$1,000 minus
