Investment description

Linked to the iShares® MSCI EAFE ETF

Unlike ordinary debt securities, the securities do not pay interest at a specified rate or repay a fixed amount of principal at maturity. Instead, the securities provide for a Redemption Amount that may be greater than, equal to or less than the Principal Amount of the securities, depending on the performance of the Fund from the Starting Price to the Ending Price.

The Redemption Amount will reflect the following terms:

If the price of the Fund increases:

You will receive the Principal Amount plus 175% participation in the upside performance of the Fund, subject to a maximum total return at maturity of 30% to 35% (to be determined on the Pricing Date) of the Principal Amount

If the price of the Fund decreases, but the decrease is not more than 10%, or equals the Starting Price:

You will be repaid the Principal Amount

If the price of the Fund decreases by more than 10%:

You will receive less than the Principal Amount and will have 1-to-1 downside exposure to the decrease in the price of the Fund in excess of 10%

Investors may lose up to 90% of the Principal Amount

How the Redemption Amount is calculated

The Redemption Amount will be determined as follows:

If the Ending Price is greater than the Starting Price, the Redemption Amount will be equal to the lesser of:

(i) \$1,000 *plus*

$$\$1,000 \times \frac{\text{Ending Price} - \text{Starting Price}}{\text{Starting Price}} \times \text{Participation Rate} \quad ; \text{ and}$$

(ii) the Capped Value

If the Ending Price is less than or equal to the Starting Price, but greater than or equal to the Threshold Price, the Redemption Amount will be equal to \$1,000

If the Ending Price is less than the Threshold Price, the Redemption Amount will be equal to \$1,000 *minus*

$$\$1,000 \times \frac{\text{Threshold Price} - \text{Ending Price}}{\text{Starting Price}}$$

In such a case, you will lose up to 90% of your Principal Amount.
