- (1) The 7,800 restricted shares are subject to vesting over a three-year period based upon satisfaction of certain performance criteria for the fiscal year ending December 31, 2006, 2007 and 2008. No more than one third of such shares may vest in the first performance period, however, the performance criteria are cumulative for the three-year period.
- (2) The Company granted to reporting person the option to purchase up to 21,500 shares of common stock vesting over a three year period on the anniversary date of the grant in equal increments.
