- (1) This share amount is comprised of 2,000 shares granted under the Ramco-Gershenson Properties Trust 2008 Restricted Share Plan for Non-Employee Trustees and 2,039 shares granted under the Ramco-Gershenson Properties Trust 2009 Omnibus Long-Term Incentive Plan.
- (2) Under the Ramco-Gershenson Properties Trust Deferred Fee Plan for Trustees, each trustee may elect to defer the receipt of all or a portion of the fees (cash and stock) earned for services until the earlier of (i) January 15 of the year following the termination of such trustee's service, (ii) the first day of the month after such trustee's retirement age, (iii) upon a change in control of the trust and (iv) upon the death of such trustee. The trustee may elect to credit any cash fees to a stock account or a cash account. Stock fees deferred can only be credited to the stock account. Mr. Blank has elected to defer only the stock-based portion of his 2011 retainer fee which is set forth in Table I above.
