(1) The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$42.60 to \$43.50, inclusive. An additional 400,000 resulted from the Corporation's two-for-one stock split to the Corporation's stockholders on May 18, 2011.
