- (1) These restricted stock units were acquired in connection with the merger (the "Merger") of Sprint Nextel Corporation ("Old Sprint") with and into a wholly owned subsidiary of Sprint Corporation (the "Issuer"). The Issuer restricted stock units were acquired in exchange for Old Sprint restricted stock units based on a conversion formula that was dependent on the trading prices of common stock of the Issuer for five days following the effective time of the Merger (the "Reference Period").
- (2) Includes 751,755 restricted stock units which are subject to forfeiture until they vest.
- (3) These stock options were acquired in connection with the Merger. The Issuer stock options were acquired in exchange for Old Sprint stock options based on a conversion formula that was dependent on the trading prices of common stock of the Issuer for the Reference Period.
- (4) Stock options vest/vested 33 1/3% on February 22, 2013, February 22, 2014 and February 22, 2015.
- (5) Stock options vest/vested 33 1/3% on April 4, 2012, April 4, 2013 and April 4, 2014.
