(1) The sales reported on this Form 4 represent shares required to be sold by the Reporting Person to cover tax withholding obligations in connection with the vesting of Restricted Stock Units (RSUs). All grants are subject to the Reporting Person's continued service with the Issuer on the applicable vesting dates.
