- (1) On March 31, 2009, Mr. Scheiwe received a grant of 17,668 shares of restricted stock in lieu of annual cash retainer pursuant to the provisions of the 2006 Non-Employee Director Stock Plan, as amended (the "Plan"). Pursuant to the terms of the Plan, 11,617 shares were forfeited by Mr. Scheiwe when he resigned from Footstar, Inc.'s Board of Directors effective immediately on May 5, 2009 following shareholder adoption and approval of a plan of complete dissolution and liquidation of Footstar, Inc.
