During the period covered by this report, the Guarantor and the Bank (and together with the Guarantor, the “Registrants”) issued on January 29, 2019, € 1,750,000,000.00 0.250% Series CB40 Covered Bonds due January 29, 2024. The joint lead managers for the transaction were Crédit Agricole CIB, Deutsche Bank, ING Bank N.V., Lloyds Bank Corporate Markets plc, RBC Capital Markets and Scotiabank Europe plc.

The net proceeds from the sale of the Series CB40 Covered Bonds were added to the Bank’s general working capital and will be used for general working capital purposes.
