The Reporting Person was granted 29,209 shares of Restricted Common Stock under the 2013 Stock-Based Compensation Plan. 9,926 time-vested restricted shares vest over a three year period as follows: 3,309 time-vested restricted shares on January 4, 2019 and January 4, 2020, and 3,308 time-vested restricted shares on January 4, 2021. 9,357 performance-based restricted shares are targeted to vest on (1) January 4, 2021 based on the Company's Total Shareholder Return versus a defined peer group of companies, with the final number of performance-based vested shares varying from 0 to 200% of 9,357. 9,926 performance-based restricted shares are targeted to vest on January 4, 2021 based on the Return on Invested Capital achieved by the Company compared to the ROIC target, with the final number of performance-based vested shares varying from 0 to 200% of 9,926.
