In the Form 4 filed on February 5, 2007, there were errors in the amounts reported in Column 5 of Table I (Amount of Securities Beneficially Owned Following Reported Transaction(s)) because of a record-keeping error by Mattel as to the running total of shares

(1) beneficially owned directly by Mr. Topham prior to the transactions. Mattel's records incorrectly reflected a running total of 4,500 shares beneficially owned directly by Mr. Topham; the correct running total was 3,700. This amendment to the February 5, 2007 Form 4 corrects the resulting errors in Column 5 of Table I.
