### **Clarification about Platforms P-65 and PCE-1**

Rio de Janeiro, June 1<sup>st</sup>, 2011 – Petróleo Brasileiro S.A. - Petrobras announces that yesterday it received a notice of interdiction for platform P-65 from the Regional Superintendency of Labor and Employment (SRTE-RJ).

Platform P-65 had already been under scheduled maintenance shutdown since May 23. It is an offloading system which receives oil that comes from the other units and does not constitute a production unit.

The items raised during the inspection performed by the SRTE/RJ had already been identified by Petrobras and the implementation of the solution of most of them is already in the completion phase. Other improvements suggested by the Superintendency will be anticipated in order to conform to the legal decisions.

The unit's scheduled maintenance shutdown does not affect the Company's oil production and Petrobras reiterates that its platforms operate within the oil industry's most rigorous standards of safety.

Moreover, Petrobras clarifies that a small leak occurred yesterday at the PCE-1 platform, located in the Enchova field. The leak of 24 liters of oily water occurred at the input line at the oil pipeline platform of Bicudo Field.

The competent agencies have already been notified of the incident at PCE-1 and the leak was immediately interrupted. The activities of the unit have already been normalized, following the clean up of the area.
