Sale of Interest in Concessions of Bijupirá and Salema

Rio de Janeiro, July 1st, 2015 – Petróleo Brasileiro S.A. – Petrobras announces that has signed today, with PetroRio S.A. ('PetroRio'), the celebration of the contracts regarding the sale of 20% of its interest in the concessions of Bijupirá and Salema fields, currently operated by Shell. The transaction amount is US\$ 25 million, subject to adjustments common in this type of operation.

Such fields are located in Campos Basin, at between 480 to 850 meters of water depths. The average daily production is 22 thousand barrels of oil and 325 thousand m³ of associated gas. The oil extracted is light, between 28^o to 31^o API.

This operation is part of the Petrobras' Divestment Plan, is related to the portfolio optimization in the Exploration and Production area, and is aligned to the 2015-2019 Business and Management Plan.

The conclusion of the purchase and sale transaction between the parties is subjected to certain preceding conditions, among which, the approval of an assignment of rights by the Board of Directors of the Brazilian Administrative Council for Economic Defense – CADE and the Brazilian National Petroleum Agency – ANP.
