Item 2.01 Completion of Acquisition or Disposition of Assets.

On April 30, 2007, CMS Energy Corporation ("CMS Energy"), completed the previously announced sale of its interest in Sistema Electrico de Nueva Esparta, C.A. including its 88 percent equity ownership interest, certain associated generating equipment and other assets. Petroleos de Venezuela S.A., which is owned by the Bolivarian Republic of Venezuela, was the buyer. The purchase price was U.S. \$105.5 million.
