The Ceridian Corporation Amended and Restated Employee Stock Purchase Plan (the "Plan") was terminated in December 2005. If no instructions were received by the Plan Agent by March 31, 2006, the Plan Agent would automatically certificate a participant's shares for a fee. The Reporting Person did not provide instructions to the Plan Agent by March 31, 2006, and the Plan Agent certificated the Reporting Person's shares held under the Plan. In connection with the certification of such shares, the Plan Agent sold the above mentioned shares to cover the certification fee.
