On July 26, 2012, 42,000 restricted stock units held by Mr. Sakhnini vested. Pursuant to the terms of his restricted stock unit award
(1) agreement, he elected to have the Company withhold 15,406 of the shares otherwise deliverable to him in order to satisfy the resulting tax withholding obligation.

Following the transaction reported on this Form 4, Mr. Sakhnini held (a) 75,000 restricted stock units, each representing the right to
(2) receive one share of the Company's common stock, (b) 75,000 restricted stock units with vesting tied to performance, each representing the right to receive one share of the Company's common stock, and (c) 26,594 shares of the Company's common stock.
