- (1) Between August 4, 2017 and December 12, 2017, the Reporting Person acquired 221 shares of DRE common stock through dividend reinvestment.
- (2) Between August 4, 2017 and December 12, 2017, the Reporting Person acquired 305 shares of DRE's common stock under the Company's 401(k) plan.  
Represents units of limited partnership interest (LTIP Unit) in Duke Realty Limited Partnership (DRLP), of which the Issuer is the general partner, issued as long term incentive compensation pursuant to the Issuer's equity based incentive programs. When earned and vested, each LTIP Unit may be converted into a Common Unit of limited partnership interest in DRLP. Each Common Unit acquired upon the conversion of an LTIP Unit is redeemable by the holder for shares of common stock of the Issuer on a one-for-one basis. LTIP units are generally not convertible until two years from the date of the grant.
- (4) LTIP Units vest in three equal installments beginning on February 10, 2018 and have no expiration date.

- (5) Represents phantom stock units acquired under the Executives' Deferred Compensation Plan of Duke Realty Services Limited Partnership. Between August 4, 2017 and December 12, 2017, the Reporting Person acquired 375 shares of DRE common stock through dividend reinvestment. The units are valued on a one to one basis to the Company's common stock and are to be settled in cash and/or stock upon the Reporting Person's termination of employment.
