(1) The reporting person was issued these shares of restricted stock pursuant to a fiscal 2009 performance-based award granted July 24, 2008, under the Brown-Forman Omnibus Compensation Plan.

In October 2008, the issuer completed a stock distribution of one share of Class B common stock for every four shares of either Class A or Class B common stock held. These stock appreciation rights were previously reported as covering 7,500 shares at an exercise price of \$68.00 per share, but have been adjusted to reflect the October 2008 stock distribution.
