- (a) Under the rules and regulations of the Securities and Exchange Commission, Mr. Boyle may be deemed to be the beneficial owner of a total of 27,874,617 shares of Issuer Common Stock. This amount includes (i) 2,000 shares held in a stock voting trust, of which Mr. Boyle is the trustee; (ii) 3,127,859 shares held in six guarantor retained annuity trusts for which Mr. Boyle is trustee and income beneficiary; (iii) 1,664,776 shares held in two trusts, of which Mr. Boyle's wife is the trustee, for the benefit of his daughter; (iv) 143,934 shares held in a trust, of which Mr. Boyle's wife is the trustee, for the benefit of his son; and (v) 834 shares held in a trust for Mrs. Boyle, of which she is the trustee. Pursuant to Rule 13d-4, this filing shall not be construed as an admission that Mr. Boyle is, for the purposes of Section 13(d) or 13(g) of the Act, the beneficial owner of the securities identified in clause (iii), (iv) or (v) of this paragraph.
- (b) Mr. Boyle's beneficial ownership of Issuer Common Stock represented approximately 39.9% of the Issuer's 69,828,235 issued and outstanding shares of such stock as of December 31, 2014.
- (c)(i) Of the total amount of shares beneficially owned by Mr. Boyle, Mr. Boyle has sole power to vote or direct the vote of 26,065,073 shares.
- (ii) Of the total amount of shares beneficially owned by Mr. Boyle, Mr. Boyle has shared power to vote or direct the vote of 1,809,544 shares.
- (iii) Of the total amount of shares beneficially owned by Mr. Boyle, Mr. Boyle has sole power to dispose or direct the disposition of 26,065,073 shares.
- (iv) Of the total amount of shares beneficially owned by Mr. Boyle, Mr. Boyle has shared power to dispose or direct the disposition of 1,809,544 shares.
