On the last day of the calendar year, the Gilead Fund held 791,700 Veracyte, Inc common shares, representing 3.52% of outstanding shares. On the last day of the calendar year, the Eventide Healthcare & Life Sciences Fund held 592,400 Veracyte, Inc common shares, representing 2.63% of outstanding shares.
