Therefore each of Mr. Tianqiao Chen, Shanda Media Limited, Shanda Investment Group Limited, Shanda Technology Overseas Capital Company Limited and Shanda Asset Management Holdings Limited may be deemed to be the beneficial owners of such common stock.

- (1) underlying common stock from the holders of such options, at such holders' discretion, and were sold by Shanda Asset Management Holdings Limited before the reporting persons became subject to Section 16.
